FOCUS ON YVY FACILITATED ENROLLMENT

YVY Facilitated Enrollment Achieves a High Ranking

As YVY's Department of Facilitated Enrollment enters its fourth year of service to the community, YVY is proud to note the progress it has made since its inception in the spring of 2007.

As an FE Lead Agency, YVY FE is able to work directly with health plans, Medicaid and the NY State Board of Health to process its clients' applications and recertifications. Despite being one of the smallest FE agencies operating in the state, YVY FE has been ranked sixth out of 15 Lead Agencies in New York City (it is the only Lead Agency in Brooklyn) and tenth out of 42 Lead Agencies in NYState. YVY FE currently processes more than 150 applications per month.

YVY FE Chosen for Pilot Online Program

YVY Director of FE Michelle Goldkrantz, LMSW, and her staff were recently asked to participate in a pilot program sponsored by the NYState Department of Health for an online application for Medicaid, Family Health Plus and Child Health Plus. YVY FE was chosen to be one of three agencies out of fifty four in the state to pilot this new program because, as the request put it, "...you and your staff are very thorough, tenacious when things get complicated, and because of your high volume of applications." YVY's IT Department stands ready to assist the FE staff with this test program.

YVY's Health Advisory Committee Meets

YVY's semi-annual Health Advisory Committee (HAC) meeting took place last November. The committee, which includes community physicians and mental health professionals as well as a representative from the YVY Policy Council, relevant YVY personnel, and community members, sets policy on health-related issues for YVY Head Start and Early Head Start.

The committee stressed the importance of early detection of developmental disabilities, particularly those on the autism spectrum. Early intervention can lead to favorable outcomes, which are harder to achieve if intervention begins when the child is older. (See related Magazine article, page 5.) The CHAT (Childhood Autism Screening Tool), a short checklist of questions physicians use to determine if a child's development is age appropriate, was distributed. Dr. Jeffrey Teitelbaum, Medical Director of YVY's affiliate Ezra Medical Center, noted that the CHAT is used routinely at Ezra, and a representative from Maimonides Medical Center reiterated their commitment to disseminate the CHAT to affiliated physicians practicing in the community.

The Committee also discussed policy issues relating to infectious disease reporting, allergic children, and immunizations.

CSBG Grant to Fund Nutrition Initiative

YVY has received a Community Service Block Grant which will be used to fund a new Nutrition Education Outreach Program (NEOP) to combat childhood obesity. This program, targeted to families that are struggling with children’s weight issues, will fund nutrition workshops in YVY Head Start and Early Head Start sites and will, in addition, provide one-to-one counseling to YVY parents of children dealing with weight issues. The program is being coordinated by YVY Director of Nutrition Service Dina Lipkind, MS, RD, CDN.

YVY parents who wish to consult the

nutritionist about a childhood weight issue can arrange for an appointment with the Family Worker at their child’s site.

YVY Research Institute Head Presents in Philadelphia

YVY Director for Research and Education Dr. Isabelle Barrier was invited to present the research she has conducted on Yiddish language acquisition at YVY by Drexel University in Philadelphia in November. Dr. Barrier’s lecture, The Acquisition of Yiddish by Hasidic Toddlers and Preschoolers: Insights into Bilingualism, was attended by faculty and students from Drexel’s Judaic Studies and Modern Languages Programs, as well as members of local Jewish organi-
